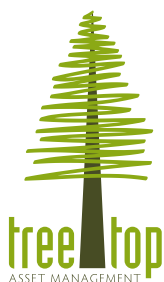


Key Investor Information

Objectives and Investment Policy

Objective: The sub-fund aims to increase the value of your investment over the long term.

Portfolio securities: Under normal market conditions, the sub-fund invests mainly in shares from issuers anywhere in the world, including in emerging markets, China and Russia. The sub-fund also invests in other types of securities that are consistent with its objective. The sub-fund may use derivatives for investment purposes or to reduce investment risks (hedging).

Investment process: Fundamental to the fund manager's approach is the belief that companies with accelerating earnings growth will deliver the best absolute returns. This points the sub-fund towards those areas experiencing high growth, or where growth is re-accelerating. The sub-fund aims to invest in about 50 to 70 companies diversified in terms of economic sectors and geographical areas.

The manager's objective is to hedge positions in currencies other than the EUR currency which represent more than 2.5% of the net asset value of the share class.

The MSCI All Country World index provides a reference of the investment universe of the fund manager. It is provided for information purpose only as indeed the sub-fund is managed on a discretionary basis and its portfolio will show a significant departure from the index.

Recommended holding period: The sub-fund may not be appropriate for investors who plan to withdraw their money within 6 years.

This share class does not distribute dividends (meaning that any income earned by the sub-fund is added to the share price).

You can place orders to buy or sell shares of the sub-fund daily.

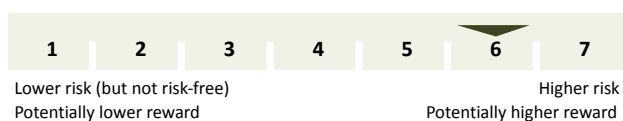
Terms to Understand

Shares: Securities that represent partial ownership in a company.

Derivatives: Contracts whose value is linked to one or more securities, interest rates, currencies, commodities or financial indices.

Hedging of positions in currencies other than the euro: Use of currency-related derivatives to reduce the effect of fluctuations in the exchange rates of these currencies in relation to the euro. This may generate gains (if the value in euros of the securities in the portfolio in another currency decreases as a result of fluctuations in exchange rates) or losses (if the value in euros increases).

Risk and Reward Profile



The sub-fund's risk/reward rating is based on its past volatility (how far, and how quickly, its price has gone up and down). Sub-fund volatility going forward could be lower or higher, and therefore its rated risk/reward level may change.

The sub-fund's risk/reward rating reflects following:

- The sub-fund invests mainly in shares,
- The sub-fund may favour particular economic sectors or regions, including emerging markets.

The risk/reward rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify the risks reflected in the risk/reward rating.

The sub-fund is also exposed to the following risks that may not be fully captured in the risk/reward rating:

Legal and tax risks: The sub-fund could be affected by foreign legal and tax changes, some of which may be retroactive.

Counterparty risk: The sub-fund could lose money if any entity with which it does business becomes unwilling or unable to honour its obligations to the sub-fund.

Charges

The charges you pay as an investor in the sub-fund go to cover sub-fund operating costs, including marketing and distribution costs. These charges reduce the performance of your investment.

For entry and exit charges, you might be eligible to pay less than the maximum amounts shown. Consult your financial advisor. Ongoing charges vary from year to year and do not include portfolio transaction costs. Ongoing charges are the same for all investors.

The ongoing charges figure shown here is an estimate. The fund's annual report for each financial year will include details of the actual costs incurred.

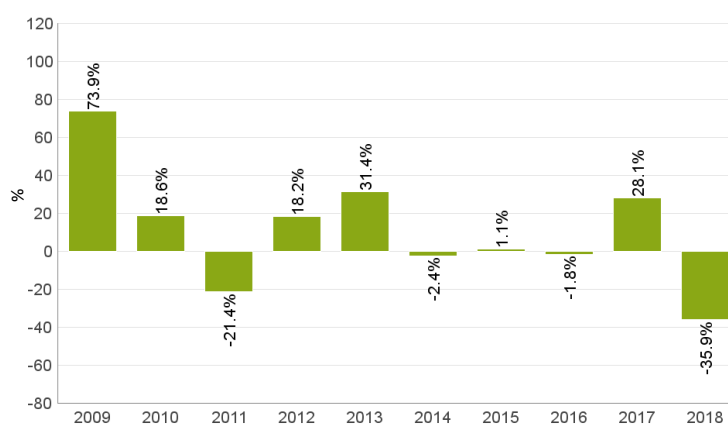
