PERFORMANCE AND NAV EVOLUTION (Class A EUR)



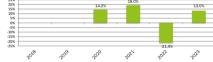

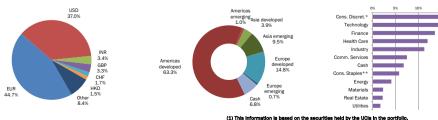
